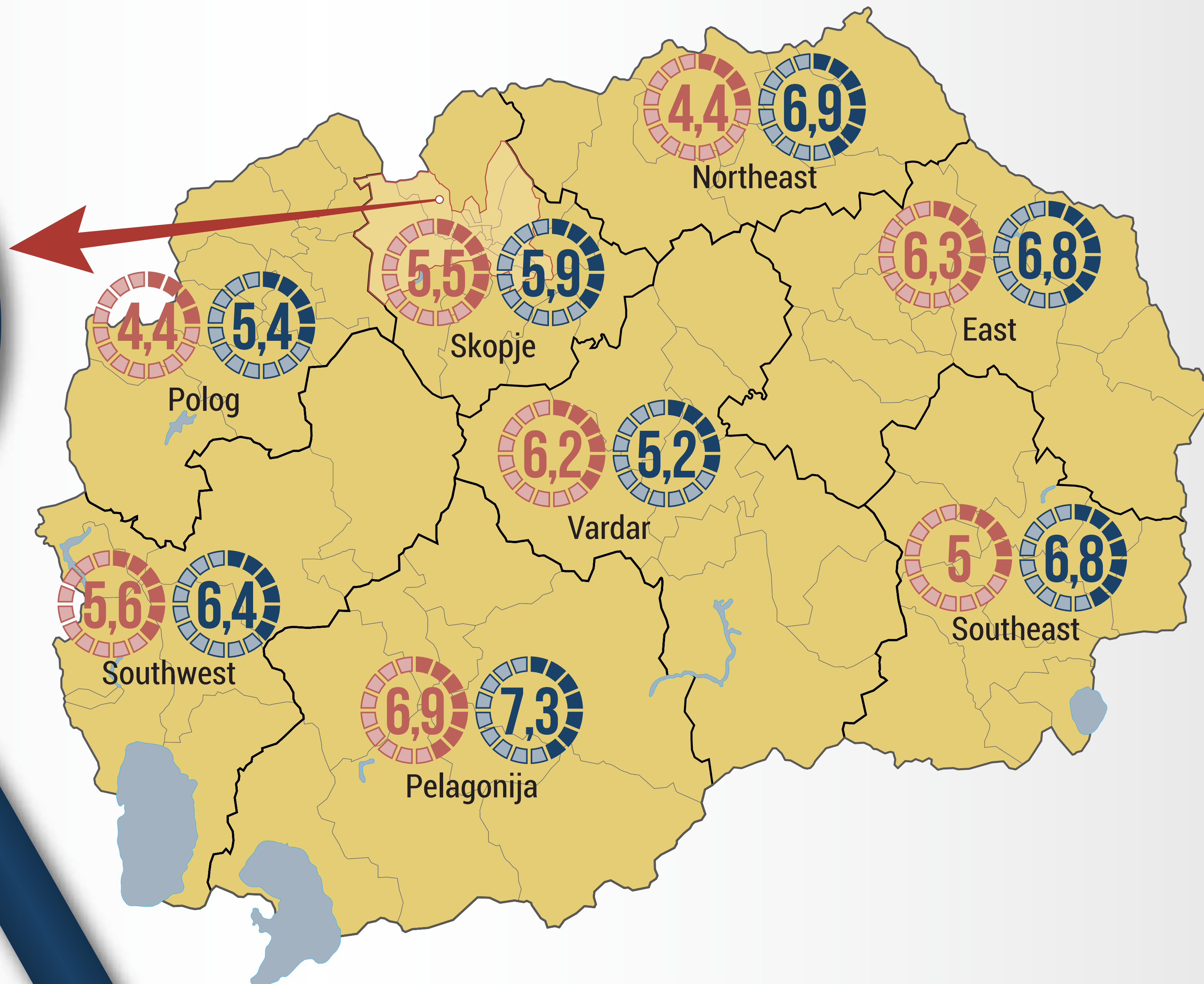


# SCORING OF AVAILABILITY OF BUDGET DOCUMENTS





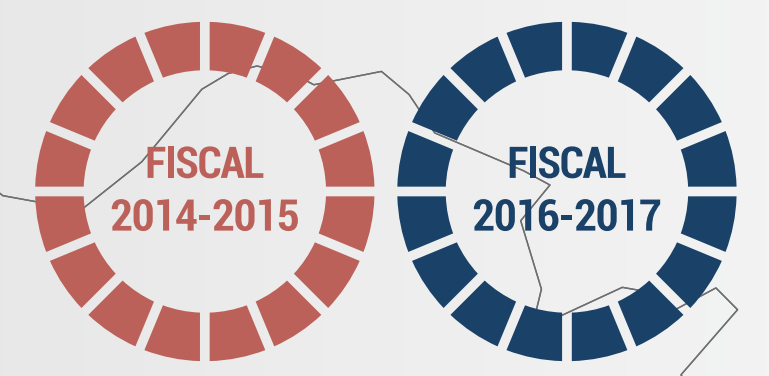
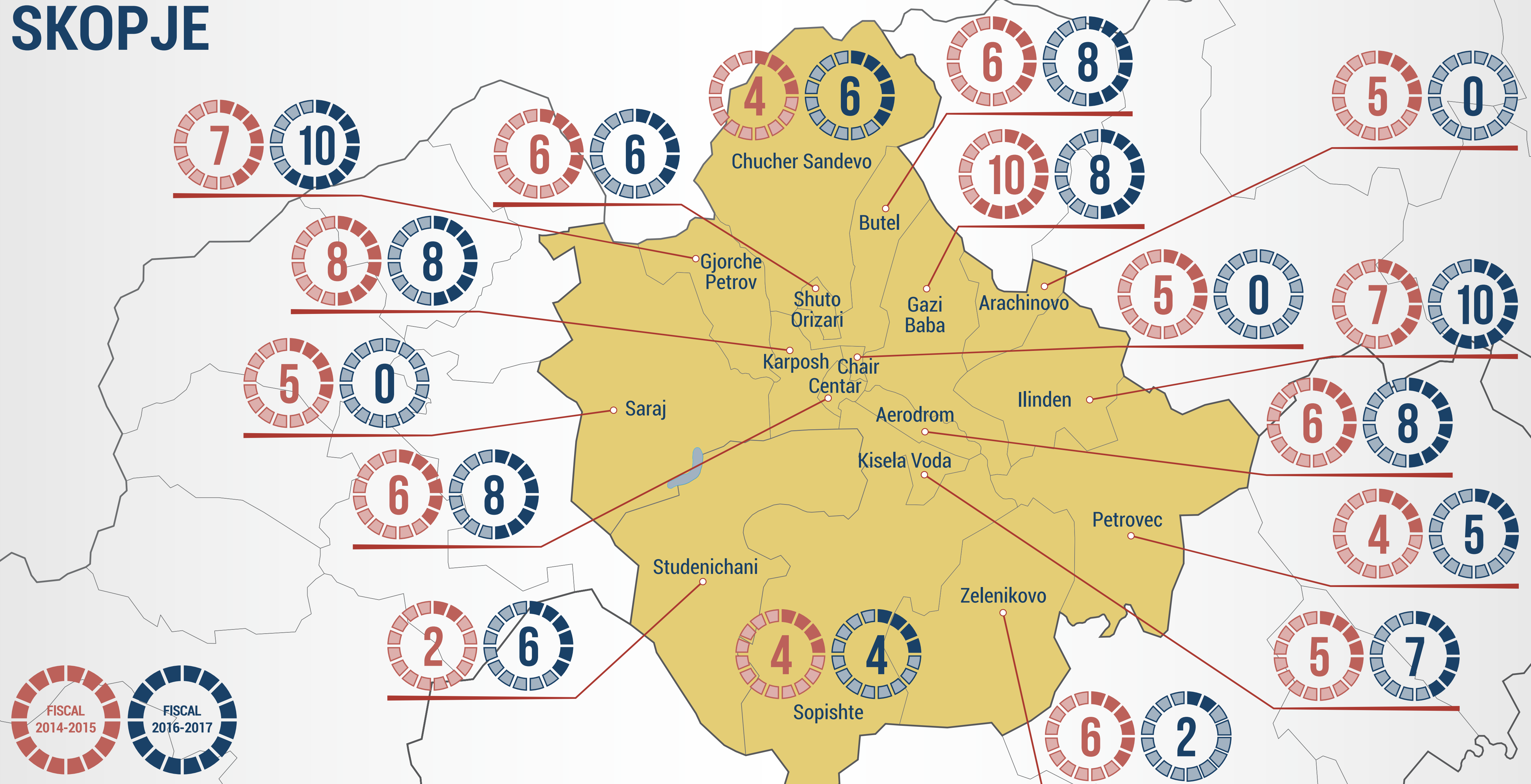
# AVERAGE INDEX OF THE AVAILABILITY OF THE MAIN BUDGET DOCUMENTS PER REGION
